### **Who can enter**

3. Subject to the clauses below, entry is open to all residents of Eastern Suburbs, St George, Sutherland Shire, Wollongong, Shellharbour and Shoalhaven Franchise Territories in Australia who have fulfilled the requirements set out below ('Eligible Entrants').
